NOTIFICATION

Application for promotion under CAS are invited in the prescribed format from eligible Assistant Professor / Associate Professors of the University satisfying / meeting the API based PBAS requirements and other eligibility conditions laid down in the UGC Regulation on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 and UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (2nd Amendment) Regulations, 2013 for consideration of promotion under Career Advancement Scheme (CAS) notified vide UGC letter No. F.3-1/2009 dated 30.06.2010, letter No. 1-2/2009(EC/PS) Pt.VIII dated 7.12.2012 vide letter No. F.102/2009(EC/PS) V(i) Vol.-II dated 13th June, 2013, and subsequently 4th amendments of UGC dated 11th July 2016 as per the following:

From Assistant Professor (Stage-1) to Assistant Professor (Stage-2) in the PB-III (Rs. 15,600 to 39,100) with AGP Rs. 7,000/-.

From Assistant Professor (Stage-2) to Assistant Professor (Stage-3) in the PB-III (Rs. 15,600 to 39,100) with AGP Rs. 8,000/-.

From Assistant Professor (Stage-3) to Associate Professor (Stage-4) in the PB-IV (Rs. 37,400 to 67,000) with AGP Rs. 9,000/-.

From Associate Professor (Stage-4) to Professor (Stage-5) in the PB-IV (Rs. 37,400 to 67,000) with AGP Rs. 10,000/-.

From Professor (Stage-5) to Professor (Stage - 6) in the PB-IV (Rs. 37,400 to 67,000) with AGP Rs. 12,000/-.

The teachers of the University who consider themselves eligible for promotion under CAS are required to submit their bio-data with duly filled in the prescribed proforma based on Performance Based Appraisal System (PBAS) enclosed as Annexure-A along with reprints of minimum three publications in case of promotion from Asst. Professor (Stage-3) to Associate Professor (Stage-4) and reprints of minimum five publications [published subsequent to the date of placement as Assistant Professor (Stage-3)] in case of promotion from Associate Professor (Stage-4) to Professor (Stage-5) in Two Sets with the relevant documents, for consideration for promotion under CAS.

The Deans of the School / Heads of the Centre / Coordinators of the Schools/Centres etc. are requested to circulate the Notification amongst the Assistant Professors / Associate Professors (including those who are on leave) and forward their applications in the prescribed format duly checked and verified about the correctness of the entries recorded therein.

The cases for promotion under Career Advancement Scheme shall be regulated as per the guidelines of the UGC contained in the UGC Regulation on Minimum Qualifications for

Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 and UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (2nd Amendment) Regulations, 2013 referred as above and subsequent amendments those received from time to time in this regard. The Regulation is available on UGC website: www.ugc.ac.in and on CUJ website: cuj.ac.in. The applicants may visit these websites and see the said Regulations for details of the scheme, eligibility requirements, application form etc. for promotion under CAS.

The application completed in all respect with required relevant documents shall be submitted to the Registrar, Central University of Jharkhand latest by 5th July, 2017.
