### 2. NOTICE FOR APPEARING CANDIDATES

- Applicants who had filled up the CUCET – 2017 application form as appearing candidate shall have to MANDATORILY come with their ORIGINAL Post-Graduation mark-sheet and proof of passing the exam with at least 55% marks (50% for SC/ST/OBC NCL/ PH applicants) on the date of interview, failing which their candidature shall stand void.
- No requests / claims in this regard shall be entertained under any circumstance.

### 3. NOTICE FOR DIFFERENTLY ABLED (PH) CATEGORY APPLICANTS

- As per Govt. of India, three percent (3 %) Horizontal Reservation is provided for Differently Abled (PH) applicants. For availing this reservation, such applicants need to produce medical certificate from the authorized medical doctor. Special care must be taken that the certificate bears the photograph of the applicant and the disability percentage. (Annexure-IV.)
- Special care must be taken that the certificate bears the photograph of the applicant and the disability percentage should not be less than 40 %.
- In case of non-providing of certificate, as per the above mentioned parameters, on the stipulated counselling-cum-admission day, the candidate shall be treated as any other regular applicant and the next applicant in the merit list, with valid certificate, shall be considered for admission in the category.
- Request for extension of date for providing the PH certificate shall NOT be entertained under any circumstance

### 4. NOTICE FOR EMPLOYED CANDIDATES

- Applicants who are employed in any capacity in any organization either government / semi-government / PSUs / University / College / NGO / or any other national or international organization, shall have to furnish '**No-Objection Certificate**' from their employer. They will be allowed provisionally to attend the interview but if selected, they shall have to mandatorily submit the same, failing which their claim for admission shall stand void and cancelled.

### 5. NOTICE FOR OBC (non-creamy layer) APPLICANTS
