CURRICULAR ASPECTS

1.1 - Curriculum Design and Development

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which is reflected in Programme outcomes (POs), Programme Specific Outcomes(PSOs) and Course Outcomes(COs) of the Programmes offered by the University

The university published its vision, mission, and quality policy in 2010-11 and these are reviewed periodically for their continued suitably and effectiveness and looking at the changing requirement of the students. All the programs offered by the university reflect this vision and mission. Students are offered a series of courses in basic sciences, engineering, management, communication, humanities, and social sciences, and tribal studies to help students in developing an understanding of scientific/engineering/management/communication/social

scientific/engineering/management/communication/social science/tribal studies principles and methods for their analytical thinking and research. The university provides core courses and specialised professional courses for enhancing skills among the students.

The core courses emphasize concepts and principles. It involves the teaching of subjects in Basic Sciences, Humanities and Social Sciences, Engineering Science, Management, Communication, and Media Studies and Tribal Studies, etc. Attention is also paid to develop communication skills in the English language - as the medium of instructions. The professional courses lay emphasis on system

analysis, design, manufacturing, and professional practice. There is in-built flexibility to encourage students to specialize in streams of their choice through a system of professional and free electives. The university strives to foster among its students a strong desire and capacity for continuous learning as well as self-appraisal to develop human and professional qualities and a strong sense of service to society through designed, curricular, co-curricular activities and congenial campus environment.

The university for better enrichment of its students and research scholar has done a number of collaborations with research labs, industries, institutes, research organisations, universities, NGOs, etc. The university has adopted the learning outcomes approach to switch the focus from content-based education and has shifted towards greater reliance on self-directed learning while involving students developing project works and assignments. Research led teaching has been evolved in terms of course content. All teaching staffs are encouraged to develop modules associated with their research area and bring in cutting edge research ideas from their own research and of other eminent researchers in their respective fields. This is being achieved by involving the students in research activities which in many cases may mean re-exploring research. However, to bring in flexibility a wide choice of electives is offered to the students in order to make their training broad based. Presentation of a seminar and a project in addition to the course work and further carrying out a thesis/dissertation are necessary components of post-graduate degree. The seminar and project should be on a topic relevant to the area of study, presenting the state-ofart work done on the subject. Emphasis is also given to carry out research on Jharkhand or local areas to strengthen the purpose of the university's wider vision. The statutory bodies of the University, the Academic Council, various Board of Schools, Departmental Research Committees oversee the design and development process of the academic curriculum so that the activity is carried out in a planned manner. Faculty members from different disciplines connected with the design and development activity are associated with the process of updating and restructuring of course curriculum keeping a balanced approach of UGC guidelines as well as local needs.

The university gives prior emphasis upon the professional ethics, human values, gender equity, environment and sustainability in its various course of studies. Various departments offer professional ethics in research as their course curriculum under for research The very purpose is that students will be able to understand the importance of ethics and values in their personal, social and professional life during and after completion of their studies. These subjects provide free environment for inculcating values and developing ethical competence among the students. It is in response to a long- felt and urgent need to integrate value education with decision making skills in their personal, social and professional life. The university for this purpose, celebrates days of national and international importance as Republic Day, Women's Day, Independence Day, Teacher's Day, Human Rights Day, Birsa Munda Jayanti, International Yoga Day, Gandhi Jayanti, Constitution Day, etc in the university premises. These celebrations nurture the moral, ethical, and social values in the students.

The University has Internal Complain Committee (ICC) to address grievances related to women working or studying in the university. It also provides counselling to students, promote gender equity among students and also deal with related issues of safety and security of female students, staff, and faculty members. The university campus is secured with CCTV and high-level security. Both male and female security guards are deployed to foster a sense of confidence among the girl students. There are separate boys and girl's hostels in the campus for providing the safe environment to all students. In almost committees, female teachers are made members to foster gender equality in the university's various policy decisions as well as its effective implementations. Along with, the university conducts various webinars related to gender sensitization, laws related to domestic violence, legal rights of women while inviting women leaders, activists, policymakers, administrators, lawyers to educate the community and make them aware of gender issues.

Regarding environment and sustainability, the university has a separate department of environment studies. The department offers various papers on environment and sustainable growth and conducts various training programme on environment issues including greenhouse effect, water depletion, rainwater harvesting, global warming, etc. The department also offers basic papers on the environment to the university students to bring awareness related to

various environmental issues. Not only this, other departments also included environment, global warming, the water crisis in their respective department course curriculum. NSS and NCC units of the university conducted tree plantation, lectures of experts in this field, Swaccha Bharat Abhiyan and poster competition on the issues of environment. Besides the syllabus, the university organized programmes to inculcate human values in students and staffs. Blood Donation Camp is regularly organized. Awareness regarding social distancing and coping with COVID-19 training is provided. NCC volunteers are sent for Disaster management, sanitizing the university premises so that the students get familiar with their social responsibility. NSS unit of the university regularly arranges various activities in the university.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences

Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences by the university. The university practices a teaching methodology which focuses on imparting education through a student centric approach. For enhancing learning experiences, the faculty members adopt many ways including classroom lecture method, interactive method, project and field work method, computer-assisted method, experimental method, etc. During closure of the university due to COVID-19, all these methods were conducted online except scientific lab-based experimentation. During online

classes and interactions, teachers used e contents, you-tube, PPTs to make learning interesting besides the conventional oral presenting methods. Final semester students of MA/MSC/MBA and others were encouraged to conduct project as part of course curriculum in online mode with strict monitoring of department HoDs and faculty concerned.

ICT enabled teaching includes Wi-Fi enabled class rooms with LCD, Language Lab, Smart Class rooms, etc. The institution adopts modern pedagogy to enhance teaching-learning process. The institution has the essential equipment to support the faculty members and students. But during the pandemic due to the particle functioning of the university online modes were used for student learning and evaluation process. To have continuous interaction with the students and monitor their progress, teachers used google meet, WebEx technology, WhatsApp. Group Learning method is now being adopted through WhatsApp group. Student share their notes and study material through this platform. Students and teachers were encouraged to participate in MOOC courses and make best use of SWAYAM platform of UGC. You- Tube, e- mails, WhatsApp group, Zoom and Google classrooms are used as platforms to communicate and platform for information dissemination, provide material and syllabus, make announcements, conduct tests, upload assignments, make presentations, address queries, mentor and share information. The library also provides access to on line journals freely available in public domain and also to journals and e books subscribed on the advice of faculty and facilitates downloads. Anti-plagiarism software is used to check authenticity of thesis submitted by scholars.

2.6 - Student Performance and Learning Outcomes

The Central University of Jharkhand enhances student learning skill by providing self-learning mode, assisted learning and hands on experience. The advanced computing, internet and Wi-Fi facilities are deployed and e-learning facilities are made available to enhance the student learning activities during the Covid-19 pandemic. The university also offers undergraduate, graduate, postgraduate and PhD programmes. Under the graduate attributes of various disciplines, the university highlights upon:

- 1. Disciplinary knowledge and skill: A graduate student is expected to be capable of demonstrating comprehensive knowledge and understanding of both theoretical and practical knowledge in various fields of interest.
- 2. Skilled communicator: The course curriculum incorporates basics and advanced training in order to make a graduate student capable of expressing the subject through technical and analytical writing as well as through oral presentation.
- 3. Critical thinker and problem solver: The course curriculum also includes components that can be helpful to graduate students to develop critical thinking ability by way of solving problems/numerical using basic subject knowledge and concepts.
- 4. Sense of inquiry: It is expected that the course curriculum will develop an inquisitive characteristic among the students through appropriate questions, planning and analysing experimental investigation.
- 5. Team player: The course curriculum has been designed to provide opportunity to act as team player by contributing to lab, field-based situation and industry.
- 6. Skilled project manager: The course curriculum has been designed in such a manner as to enabling a graduate student to become a skilled project manager by acquiring knowledge about project management, writing, planning, study of ethical

- standards and rules and regulations pertaining to scientific and social project operation.
- 7. Digitally literate: The course curriculum has been so designed to impart a good working knowledge in understanding and carrying out data analysis, use of library search tools, and use of software and related to other computational work.
- 8. Ethical awareness/reasoning: A graduate student requires to understand and develop ethical awareness/reasoning which the course curriculum adequately provide.
- 9. Lifelong learner: The course curriculum is designed to inculcate a habit of learning continuously through use of advanced ICT technique and other available techniques/books/journals for personal academic growth as well as for increasing employment opportunity.

2.6.2 - Attainment of Programme outcomes, Programme specific outcomes and course outcomes are evaluated by the institution during the year

The Central University of Jharkhand has a system in place for measuring the levels of attainment of course outcomes, programme specific outcomes and programme outcomes. The course outcomes are measured through syllabus, completion of syllabus, continuous evaluation (internal evaluation), setting up of question paper, evaluation, and result. At the Departmental level the Heads of the Department and the teachers who are engaged in any class strive to complete the courses in time and in some cases extra classes are conducted for the students who they identify as relatively average. The 75 percent of compulsory attendance to qualify for writing the examination of the courses is mandatory to ensure student's participation in the class. The continuous evaluation is done through tests, written assignments, presentation of papers, oral presentations, field work, dissertations, and so on. The end semester examination of every course is based on written examination of three hours, the question paper of which is required to test the knowledge of the student from every unit prescribed for study. The programme specific outcomes is measured by taking the aggregate result of all courses in a given programme of an individual student, and then the average performance of all the students in a given programme.

The general programme outcomes for PhD programmes all across the disciplines of study in the University are that the scholars make

contribution to the existing body of knowledge by discovery, innovation, problem solving, establishing of new perspective etc. The number of students completed PhD during the period of assessment is evidence of the attainment of the programme outcomes. University has introduced online feedback system for the students to help the university in measuring the attainment of the programme outcome. The online student feedback system provides information pertaining to the relevance of the course, availability of the course material, and course's importance in terms of employability and so on which are pertinent questions and which help the University measures its learning outcomes.

3.1 - Promotion of Research and Facilities

3.1.1 - The institution Research facilities are frequently updated and there is well defined policy for promotion of research which is uploaded on the institutional website and implemented

Development of research is a priority area for the Central University of Jharkhand. Research activities are promoted at department levels through curriculum based undergraduate/graduate/post graduate and PhD research projects and internship projects. The university promotes research by faculty as well as students through its various research committees like

Research Advisory Committee (RAC), Doctoral Research Committee (DRC), Board of Research (BoS), School Boards (SBs), Academic Council (AC), etc. The Research committee (RC) takes care of various issues of research including research ethics. The committees comprise of a core group of academic members of the university and an extended group consisting of the head/dean of every department/school. All the research committees are monitored by university highest authorities.

The university also facilitates the participation of the faculty members in seminars, conferences, workshops, etc. at national and international levels. It helps in conducting departmental seminars and community outreach programmes as well. The university encourages staff and students to travel national and international conferences to present their research work. Research projects are encouraged to fetch from UGC, ICSSR, DST, etc. not only this the university focuses on,

- advancing funds for sanctioned projects,
- providing advance money to the project directors
- simplification of procedures related to sanctions / purchases to be made by the investigators,
- autonomy to the principal investigator/coordinator for utilizing overhead charges
- timely release of grants
- timely auditing
- Submission of utilization certificate to the funding authorities.

The university has developed PhD regulations and it is instructed to all the departments that Research Advisory Committee of the PhD students to be held periodically in each six months and students progress to be reviewed regularly.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The Central University of Jharkhand (CUJ) presently operates from its two campuses. The Humanities and Social Science departments are operating from the permanent campus at Cheri Manatu, the Science, Engineering, Management and Media Study Departments are operating at temporary campus of Brambe. The university provides ICT enabled classrooms and lab facility to all most all the departments. The university has its library in temporary campus at Brambe since its inception. The library has a good number of books, journals, and periodical and subscribes to a large number of e- databases. The library has developed its own website to provide internet-based services for wider accessibility to its resources to students and staffs. The library is connected with Wi-Fi and students as well as employees get ample benefit out of it. CUJ has established a Data Centre and it is connected to National Knowledge Network (NKN) through optical fibre link with a bandwidth of 1GBPS. The University provides 24-hour Network and authenticated internet access to all employees and students placed at different departments and hostels on campus. A well-established Datacentre is placed at CUJ campus that includes 7 servers for Network and System administration. entire CUJ campus is networked through optical fibre and powerful layer 3 / layer 2 (managed & unmanaged) Cisco switches and Routers housed at the CUJ Data centre. The network is secured through a Hardware firewall. The University provide 24 hours Network and Authenticated Internet access to all its employees and students placed at different departments of campus, Hostels , Staff Quarters. CUJ has established computer laboratory for student

4.1.2 - The institution has adequate facilities for cultural activities, yoga, games (indoor, outdoor) and sports. (gymnasium, yoga centre, auditorium, etc.)

The university has one indoor sports complex, one ground for multipurpose activity, one football ground (50m x 20m), two concrete pitches (7.5ft x 30 ft) of cricket for training. To improve the physical fitness of students and employees, the University has provided a well-equipped Gym in its temporary campus. To encourage students and staffs participation in sports, the University also provides Yoga training to its community and celebrates Yoga Days to encourage students and staffs to practice yoga in everyday life. There are three indoor gyms and a large sports arena with coaches in eight different sports disciplines. Indoor sports training rooms have also been developed. These include three separate gyms for staff, for boys and for girls. There is a 400 seat auditorium at Central University of Jharkhand temporary campus at Brambe, equipped with lightening system, audio system, Internet facility, Projection System and video conferencing system which provides outstanding acoustics and clear sightlines from all seats. Apart from academic programs like Seminar, conferences etc, the Auditorium also hosts cultural programs, Plays, Musical Performance etc.

4.1.3 - Availability of general campus facilities and overall ambience

The present campus of the University is located at Brambe, a 25 kilometre drive from Ranchi City. It is a beautiful and vibrant green campus, with its classrooms and hostels blending well with the environment. In order to cater to the need of the academics, the University has erected class rooms, hostels and staff quarters with pre-fab material. The Govt. of Jharkhand has transferred 319.28 acres of land to CUJ for its permanent campus on 22.10.2011. A total of 500 acres has been earmarked for the University at Cheri — Manatu, Ranchi, and is about 10 kms from the Centre of the city. The construction work of academic, library and administrative buildings is under progress.

The permanent campus is located on rocky hilly terrains. The Brambe campus is beautifully designed with trees, lawns, gardens and it is

almost green and pollution free campus, whereas plantation work is in progress in CUJ campus at Cheri-Manatu. The Brambe campus provides for the faculty and students a serene ambience to reside and access classrooms, laboratories, library, health centre, sports ground, gym, student managed cafeteria, banks with ATM facilities, yoga centre, etc.

To avoid wastage of rain water and reduce degradation of water, a major reservoir is there which is spread over 10 acres, with an average depth of 30 feet to drain the rain water passing through different parts of the campus and adjoining areas. The natural landscape ambience has been protected and maintained while constructing new buildings in the main campus and parking facilities have been developed for vehicle parking. CUJ has a basic Health Care Centre to provide medical support to needy students with ambulance facility to its students, faculty and staff and their family members. Further, the university has empanelled various super specialty hospitals situated at Ranchi to provide medical facilities to its community. Most of the buildings in the campus have ramps, lifts and toilets for differently-abled students and staffs. Efforts are underway to provide lift facility in all the buildings of the main campus.

There are different types of quarters provided to teachers, staffs as per their eligibility. Along with quarters are provided to university authorities as well as officers inside the university campus as well as in Ranchi city. University also has a wellfurnished guest house in the Brambe Campus. The university has hostels for boys and girls separately and separate hostels for both male and female research scholars. Hostels are also beautifully designed in main campus of CUJ with modern facilities. The Brambe campus has well equipped auditorium and main campus has conference rooms to conduct various meetings, conferences, workshops, etc. Solar panels have been installed in our campus as a source of renewable energy. Highest standard of maintenance of the toilets is daily carried out by outsourced staff. Sufficient and separate toilets are constructed for students and staffs in both administrative, academic buildings, libraries, health centres, hostels, etc. Sanitary vending machine is installed in lady's toilet in administrative buildings and under process to fix in other buildings. Campus has Wi-Fi facilities for all students and staff members to enable all education services easier.

Brambe campus is connected to National Knowledge Network (NKN) through optical fibre link with a bandwidth of 1 GBPS and Manatu Campus is connected to 200 Mbps. A well-established Data Centre has been located at CUJ Brambe campus since 2011 that includes 7 servers for Network and System administration. The entire CUJ campus is networked through optical fibre and powerful layer 3 / layer 2 (managed & unmanaged) Cisco switches and Routers housed at the CUJ Data Centre. The network is secured through a Fortigate firewall to provide 24 hrs authenticated internet services.

Technical Wing of Central University of Jharkhand acts as the Central hub for all technical support requirements of the university. The Technical Wing maintains the Information Technology infrastructure of the University such as computer hardware and peripherals, servers, networking devices etc. The maintenance and updating of official website of the university is also vested with this department. We provide complete web service support for the online activities such as e-learning, webinars etc. Technical Wing provides various services to Faculty members, staff and students of the University along with the automation of existing with a view for

improving productivity, reducing expenses and optimising the workloads through MoE initiative project Samarth .

University is functioning partially from both campuses. University has signed a MOU in the year 2020-21 with BSNL for a period of 5 years to complete all the Internet network related activity for the permanent Manatu campus with an estimated budget of Rs 5 crore approx.

University has allotted an additional 5 lacs fund for strengthening the WiFi and network infrastructure of Brambe Campus and 5 lacs for Centralized Antivirus, Software, Online meeting and Microsoft office products. Further University has also allotted Rs 40 lacs to procure interactive panel/whiteboard for classrooms and Rs 10 lacs for ICT enabled Central Audio Video conference hall/studio and Rs 25 lakhs for Computers for related software, language laboratory and resource centre etc.

University has not yet finalized the IT policy and it is in a planning and draft phase and the same will be finalized in due course of time.

Supporting staffs are recruited by the panel consisting of the Vice-Chancellor, The Registrar, Deans of Schools, Head of the Departments.
