The meeting started with formal welcome by the Chairperson of the Board of Studies (BoS) of the DIR. He then presented the Agenda before the esteemed members of the BoS for discussion and deliberation. Agenda item is attached-with the MoM. Following discussions took place and decisions/recommendations were arrived at:

- 1) Agenda as mentioned in Annexure-I to this Minutes of the Meeting(MoM) were discussed and resolution as mentioned against each were arrived at.
- 2) A detailed discussion took place regarding Agenda No.9 to introduce a Certificate Course on International Political Risk Analysis by the Department of International Relations under the School of Humanities and Social Sciences. Prof. Chintamani Mohapatra suggested that: (i) The Course must be open to all professionals; (ii) A detailed proposal of the course need to be prepared and also figure out who can opt for this course; (iii) The details regarding mode such as self-finance or any other must be specified along with details budget including the fee-structure; (iv) The faculty members who can teach the proposed course must also be identified. VratSingh suggested in the same line and asked to figure out duration of the course, numbers of seats to be provided, fee structure, objective and overall curriculum of the course. Accordingly, all the members in principle agreed on the proposal to introduce a six months Certificate Course after the above-mentioned suggestions are approved in the next BoS.

- 3) Part-time Ph.D. Programme under Agenda No. 10 was discussed. The members observed that as the UGC has clear guidelines regarding starting Part-time Ph.D. and Central University of Jharkhand has adopted it, therefore, proposal of adopting the same for the Department of International Relations stands approved by the Board.
- 4) Agenda No.11 related to transfer of research scholar from Department of International Relations to Department of Political Science and Public Administration was discussed. The Chairperson explained the matter before the Board that two of the faculty members have been transferred from Department of International Relations to Department of Political Science and Public Administration, namely Dr. Alok Kumar Gupta and Dr RajashreePadhi, therefore, Ph.D. scholars registered under them may be reallocated to Department of Political Science and Public Administration. The Board Members observed that since the University has adopted a regulation of such kind, hence the matter may be resolved accordingly.
- 5) The Board Members were of the opinion to adopt New Education Policy-2020 in the Two Years M.A. Programme in the Department of International Relations. Members also suggested that in due course of time Integrated UG/PG as per National Education Policy-2020 may be started by the Department.
- 6) Meeting ended with thanks to respective external members, internal members and the Chair.


