
NOTIFICATION

5.	Three persons to be nominated by the Visitor	i) Joint Secretary and Finance Adviser, MHRD, or his/her nominee from Finance Bureau of MHRD not below the rank of Deputy Secretary. ii) Joint Secretary (CU & L) of MHRD, or his/her nominee not below the rank of Joint Secretary to the Govt. of India. iii) Joint Secretary (CU), UGC or any other Joint Secretary level Officer nominated by the Chairman, UGC.
6.	Finance Officer - Secretary	Finance Officer- Secretary (Ex-Officio)

All the members of the Finance Committee, other than ex-officio members, shall hold office for the remaining period of the existing term of three years, i.e. upto 02.10.2016 only.
