
It hardly needs any mention that utmost austerity measures should be followed whilst spending public resources for the growth and development of the institutions. The Ministry of Finance, Department of Expenditure, Government of India has been issuing austerity instructions from time to time which inter-alia, stipulate urgent need for rationalization of expenditure and optimization of available resources. Such measures are needed at promoting fiscal discipline, without restricting the operational efficiency of the Government. Therefore, there is a need to continue to rationalise expenditure and optimize available resources.

The economy instructions are required to be followed *mutatis mutandis* by all Universities funded by the Government of India. It has been brought to the notice of the UGC that some of the Universities are incurring the lavish expenditure on various visiting committees which is highly unethical. It is, therefore, urged that utmost economy needs to be observed to facilitate work of visiting committees in respect of their boarding & lodging as well as in hiring of vehicles. Sincere efforts may be made to provide accommodation in the University Guest House besides encouraging sharing of vehicles.

I would, therefore, request you to kindly attend to this personally and ensure that these economy instructions are followed scrupulously. I shall be grateful for an early response indicating the action taken in this regard.
