## **Relaxation clause:**

- 1. A relaxation of 5% marks may be provided at Graduate and Master's level for the Scheduled Caste/ Scheduled Tribe/Differently-abled (Physically and visually differently-abled)/Other Backward Class (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record during engagement of temporary faculty. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% marks to thecategories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
- 2. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.
- 3. Relevant grade which is regarded as equivalent of 55% marks wherever the grading system is followed by a recognized university shall also be considered eligible.

Candidates claiming to belong to OBCs/SEBC should note that the name of their Caste (including its spellings) as indicated in their certificates, should be exactly the same as published in the lists notified by the Central Government from time to time. A certificate containing any variation in the Caste name will not be accepted.
- 4. The OBC/SEBC claim of a candidate will be determined in relation to the State (or part of the State) to which his/her father originally belongs. A candidate who has migrated from one State (or part of the State) to another should, therefore, produce an OBC certificate which should have been issued to him/her based on his/her father's OBC/SEBC certificate from the State to which he (father) originally belongs

Candidates registered for the Ph.D programme prior to July 11, 2009, shall submit a certificate in the prescribed format (**Annexure-II**) from concerned University/Institute in accordance with the University Grants Commission on minimum qualifications for appointment of teachers and other academic staff in universities and colleges and measures for the maintenance of standards in higher education (3rd Amendment), Regulations, 2016.
- 4. CUJ reserves the right to cancel all and / or modify Interview of any department without assigning any reason thereof.


