 - III. The minimum qualifying marks to be secured in Paper I shall be 40% for UR, 35% for OBC (NC) & EWS and 30% for others. The answer scripts of the candidates for the Paper-II shall be evaluated only in respect of those candidates who secure the minimum qualifying marks in Paper I. The minimum qualifying marks in Paper – II shall be 50% for UR, 45% for OBC (NC) & EWS and 35% for other category.
 - IV. The merit list of the candidates shall be drawn based on the performance in Paper II (descriptive test) only.
 - V. PwD candidates will be allowed Scriber and extra time for written test as per Govt. of India Rules.

This component may include questions on analogies, similarities and differences, problem solving, analysis, judgment, decision making, discrimination, observation, relationship concepts, arithmetical reasoning, arithmetic number series, coding and decoding, statement conclusion Indexing, Address matching, Date & City matching, Classification of center codes/roll numbers, Small & Capital letters/numbers coding, decoding and Classification and Critical thinking.

There will be no component of Maps/Graphs/Diagrams/Statistical Table in the General Intelligence and Reasoning/Quantitative Aptitude.

B. Indicative Syllabus of Paper – II (Descriptive Type Test): 100 Marks

Knowledge of disaster management techniques, Handling of fire-fighting devices and installation of fire extinguishers, Proper handling of licensed weapons-training and management of security personnel deployed for University security. Decorum and discipline of security staff – protocol norms for Independence Day and Republic Day celebrations, Security check points and strategies for full proof entry and exit system, Smooth transportation / movement within the campus-Administrating over all discipline in the campus, other areas relevant to the post.

Selection Criteria and Scheme of Examination for the direct recruitment for the post of Driver (Group C), Pay Level – 1.

1. **General Descriptions:**
 - I. The selection process shall consist of following Papers:
 - A) Objective Type Test (Paper – I)
 - B) Descriptive Type Test (Paper – II)
 - C) Skill Test
 - II. The Objective type test (Paper – I) shall be conducted first which will be of qualifying nature.
 - III. The minimum qualifying marks to be secured in Paper I shall be 40% for UR, 35% for OBC (NC) &EWS and 30% for others. The answer scripts of the candidates for the Paper-II shall be evaluated only in respect of those candidates who secure the minimum qualifying marks in Paper I. The candidates who secure minimum qualifying marks in Paper – II (i.e. 50% for UR, 45% for OBC (NC) &EWS and 35%for other category) shall be called for the Skill test.
 - IV. The skill test is qualifying in nature. The merit list of the candidates shall be drawn based on the performance in Paper II (descriptive test) only.
 - V. PWD candidates will be allowed Scriber and extra time for written test as per Govt. of India Rules.
 - VI. The standard of questions will be of level as per essential qualifying degree / experience required for the post.
 - VII. Medium – English and Hindi (Except English Paper).
 - VIII. In case of Tie where more than one candidate secures the equal aggregate marks, the tie will be resolved by applying the following methods one after another:-
 - a) By referring to the marks in Section B of the descriptive type written test.
 - b) By referring to the marks in Section A of the descriptive type written test.
 - c) Date of birth i.e. the candidate older in age gets preference.
 - d) By referring to the alphabetical order of the names taking first name into consideration.

2. **Scheme of Examination and Syllabus:**

The examination will consist of two papers, Paper – I (Objective type test) of 90 marks and Paper – II (Descriptive type test) of 100 marks.

There will be no component of Maps/Graphs/Diagrams/Statistical Table in the General Intelligence and Reasoning/Quantitative Aptitude.

Letter and Essay writing in Hindi and English language.

C. Skill Test:

This test will assess the candidates' driving skills and test his/her knowledge of motor driving, motor mechanics and traffic rules & regulations.

EVALUATION OF STENOGRAPHY TEST (ENGLISH / HINDI)**NATURE OF MISTAKES**1. **FULL MISTAKES:** The following mistakes are treated as full mistakes:

- Every omission of word or figure. In case a group of words is omitted, mark as many mistakes as the actual of words omitted.
- Every substitution of a wrong word or figure. The number of mistakes will be equal to the number of words / figure dictated which have been replaced / submitted by other words(s) / figure(s). However, if a figure is written correctly either in numeral or words both will be acceptable and will not be counted as mistake.
- Every addition of a word or figure or a group of words or figures not occurring in the dictated passage.

2. **HALF MISTAKES:** The following are treated as half mistakes:

- Wrong spelling, including transcription of letters in a word and also omission of a letter or letters from a word. Mis-spelling of proper nouns and unfamiliar names are ignored. If the wrongly spelt word occurs more than once in the passage it will be treated as a single half mistake.
- Using singular or plural noun and vice versa.
- Use of small letter at the beginning of the sentence.

NOTE

- More than one error in a single word: All the errors are counted but the total mistakes counted in a single word not exceed one full mistake.
- Every passage will be accompanied by a list of words which can be spelt / written in more than one form. All the spellings / forms of words will be acceptable and not counted as error. For example the word 'Honourable' is written as Hon'ble, Hon., hounourable and hon. – all these forms will be treated as correct.
- CANDIDATES ARE NOT PENALISED FOR ANY TYPE OF ERRORS OR MISTAKES OTHER THAN THOSE DESCRIBED ABOVE.
- The above guidelines will be valid for Hindi Stenography Skill Test also.
- Method of calculation of mistakes in Stenography Skill Test: -

$$\text{Percentage of Errors} = \frac{(\text{Full Mistakes} + \text{Half Mistakes}/2) \times 100}{\text{Number of words in the master passage}}$$

Percentage will be rounded off to two decimal places. For example 5.009 will be treated as 5.01 and 5.001 will be treated as 5.00.

EVALUATION OF TYPE (ENGLISH/HINDI)

NATURE OF MISTAKES

A. **Full Mistakes:** The following errors are treated as full mistakes:--

- For every omission of word/ figure.
- For every substitution of a wrong word/figure.
- For every addition of a word /figure not found in the passage.

B. **Half Mistakes:** The following errors are treated as half mistakes:--

- (i) **Spacing Errors:** Where no space is provided between two words, e.g. 'Ihope' or undesired space is provided between the words or letter sofa word e.g. hope Ihave, 'I hxxave'.
- (ii) For every spelling error committed by way of repetition, or addition or transposition or omission or substitution of a letter/letters, e.g. the word 'spelling' typed as 'seeplings' etc.
- (iii) **Wrong Capitalization:** Wrong use of capital letter for small letter and vice-versa. (This does not apply to Hindi typewriting scripts).

C. **Evaluation Procedure:**

The following parameters and formulae shall be used to calculate the speed and accuracy of the typing test conducted, wherever applicable.

- i. Gross Words: This is the total number of words typed by the Candidate: it includes both correct and incorrect words.
Gross Words is calculated as: typed words.
- ii. Gross Words per min (GWPM): The Total number of words typed in one minute.
GWPM is calculated as: Gross Words/Time taken in minutes
- iii. Net Words: The number of correct words typed.
Net Words is calculated as: Correct Words
- iv. Net Words per min (NWPM) = Net Words / Time taken in minutes
- v. Accuracy: The number of correct words entered.
Accuracy of content is calculated as: $NWPM \times 100 / GWPM$

Sample Illustration of above formula are as follows:

Candidate A typed total 350 words out of which 342 are correct and 08 are incorrect in a duration of 10 minutes. Hence,

Total Typed Words = 350

Correct Words = 342

Incorrect Words = 8

Gross Words per Minute (GWPM) = $350/10 = 35$ words per minute

Net words per Minute (NWPM) = $342/10 = \mathbf{34.2}$ words per minute

Accuracy = $34.2 \times 100 / 35 = \mathbf{97.72\%}$

- * The University has fixed the category wise cut-off on percentage of errors / mistakes allowed in Typing Skill Test (English / Hindi) in the following manner:

Mistakes to the extent of aforesaid percentage of the total words typed will be ignored and thereafter for every full or half mistake, corresponding number of words will be deducted from the total words typed for arriving at the final speed.

- * For the Physically handicapped persons, these instructions provide from exemptions as per the O.M. of DoPT, Ministry of Personnel, Public Grievances and Pensions, Govt. of India dated 22nd April, 2015 as under: -

Physically handicapped persons who are otherwise qualified to hold clerical post and who are certified as being unable to type by the Medical Board attached to Special Employment Exchanges for the Handicapped (or by a Civil Surgeon where there is no such Board) may be exempted from passing the typing test.

The term 'physically handicapped persons' does not cover those who are visually handicapped or who are hearing handicapped but cover only those whose physical disability permanently prevents them from typing.

NOTE: Any corrections made by pen or pencil in the printed paper of typed passage are ignored and no credit is given to such corrections.
