IMPORTANT NOTICE TO THE APPLICANTS APPLIED FOR THE POST OF PROFESSOR & ASSOCIATE PROFESSOR IN CENTRE FOR HINDI

The University vide its Advt. No. CUJ/Advt./2016-17/17 dated 17.02.2017 advertised the Teaching Positions at the level of Professor and Associate Professor in the Centre for Hindi.

- 1. The Screening Committee checked and verified the records of each applicant and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Advt. No. CUJ/Advt./2016-17/17 dated 17.02.2017; UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 (herein after referred to as UGC Regulations) and its subsequent amendments issued in year 2011/2013/2016 published in the Gazette of India.
- 2. Applicants not meeting the minimum eligibility requirements as per the UGC Regulations were declared Not Eligible and reasons for declaring an applicant as ineligible are clearly indicated against their names.
- 3. The list of all applicants who have applied for the position of **PROFESSOR** in the Centre for Hindi, giving general information and decision of the Committee with regard to their eligibility and non-eligibility along with the reasons thereof is placed at **TABLE 1.**
- 4. The list of all applicants who have applied for the position of **ASSOCIATE PROFESSOR** in the Centre for Hindi, giving general information and decision of the Committee with regard to their eligibility and non-eligibility along with the reasons thereof is placed at **TABLE 2**.
- 5. Since the number of eligible applicants for the positions of Professor and Associate Professor in Centre for Hindi is not very large, the Screening Committee decided that all eligible applicants who meet the minimum eligibility requirements may be called to appear before the Selection Committee.
- 6. All the minimum eligibility conditions except API Score have been checked and verified as per UGC Regulations 2010 as amended from time to time. However, with respect to API Score, it is observed that since many applicants have not attached specific/necessary documents or not filled the requisite information in proper way, therefore, the Screening Committee decided that all applicants who have claimed API Score of 400 and 300 for the post of Professor and Associate Professor respectively, were considered PROVISIONALLY ELIGIBLE with the condition that the applicants shall have to substantiate their claim through documentary proof at the time of Interview, if called for.
- 7. It may be noted that: (a.) Decision with regard to Short-listing of applicants, has been made on the basis of their claim/information/certificates furnished/attached in their application forms.(b.) Further, while deciding as to whether an applicant is eligible or not, the Committee has considered the educational qualification, experience, percentage of marks, category etc. furnished by the candidates.(c.) Applicants shall have to substantiate their claim through documentary proof at the time of the Interview. (d.) Applicants must ensure that their details are correct and that they meet the minimum eligibility requirements, failing which they shall not be allowed to appear for Interview before the Selection

Committee. (e.) The eligibility of the applicants has been determined as on the last date of receipt of applications.

- 8. Applicants are advised to go through their details carefully given in Table1 & Table2 and in case of any discrepancy, the applicants are advised to bring the same to the notice of the University for necessary correction(s) clearly mentioning the name of post, name of the department and page no. at which their names figures in the list by writing an email to recruitmentcell@cuj.ac.in latest by 10th August, 2017.
- 9. NO REQUEST FOR CORRECTIONS AND/OR IMPROVEMENT SHALL BE ENTERTAINED AFTER $10^{\rm th}$ August, 2017.
- 10. Although all efforts have been made to ensure accuracy in preparing the lists mentioned at Para 3 and 4 above, possibility of inadvertent error or typographical mistake/ omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any, on receipt from applicants.
