

IMPORTANT NOTICE TO THE APPLICANTS APPLIED FOR THE POST OF ASSISTANT PROFESSOR IN CENTRE FOR LAND RESOURCE MANAGEMENT

The University vide its Advt. No. CUJ/Advt./2017-18/03 dated 24.05.2017 advertised the Teaching Positions at the level of Assistant Professor in the Centre for Land Resource Management.

1. The Screening Committee checked and verified the records of each applicant and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Advt. No. CUJ/Advt./2017-18/03 dated 24.05.2017; UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Land Resource Management 2010 (herein after referred to as UGC Regulations) and its subsequent amendments issued in year 2011/2013/2016 published in the Gazette of India.

2. Applicants not meeting the minimum eligibility requirements as per the UGC Regulations were declared Not Eligible and reasons for declaring an applicant as ineligible are clearly indicated against their names.

3. The list of all applicants who have applied for the position of **ASSISTANT PROFESSOR** in the Centre for Land Resource Management, giving general information and decision of the Committee with regard to their eligibility and non-eligibility along with the reasons thereof is placed at **TABLE 1**.

4. Since the number of eligible applicants for the positions of Assistant Professor in Centre for Land Resource Management is large, it has been decided that only **12** candidates are to be called for interview as per Ordinance of the University. However, on the basis of merit, on the 12th position there were 2 candidates with same points so list of **13** candidates have been prepared in accordance with the criteria for shortlisting given in **ANNEXURE –I**.

5. All the minimum eligibility conditions except API Score have been checked and verified as per UGC Regulations 2010 as amended from time to time. However, with respect to API Score, it is observed that since many applicants have not attached specific/necessary documents or not filled the requisite information in proper way, therefore, the Screening Committee decided that all applicants who have claimed API Score of Nil for the post of Assistant Professor, were considered **PROVISIONALLY ELIGIBLE** with the condition that the applicants shall have to substantiate their claim through documentary proof at the time of Interview, if called for.

6. It may be noted that: (a) Decision with regard to Short-listing of applicants, has been made on the basis of their claim/information/certificates furnished/attached in their application forms.(b) Further, while deciding as to whether an applicant is eligible or not, the Committee has considered the Land Resource Management qualification, experience, percentage of marks, category etc. furnished by the candidates.(c) Applicants shall have to substantiate their claim through documentary proof at the time of the Interview. (d) Applicants must ensure that their details are correct and that they meet the minimum eligibility requirements, failing which they shall not be allowed to appear for Interview before the Selection Committee. (e) The eligibility of the applicants has been determined as on the last date of receipt of applications.

7. Applicants are advised to go through their details carefully given in Table 1 and in case of any discrepancy, the applicants are advised to bring the same to the notice of the University for necessary correction(s) clearly mentioning the name of post, name of the department and page no. at which their name figures in the list by writing an email to recruitmentcell@cuja.ac.in latest by December, 2017 along with copy of supporting documents.

8. NO REQUEST FOR CORRECTIONS AND/OR IMPROVEMENT SHALL BE ENTERTAINED AFTER December, 2017

9. Although all efforts have been made to ensure accuracy in preparing the lists mentioned at Para 3 above, possibility of inadvertent error or typographical mistake/ omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any, on receipt from applicants.

10. Call Letters to short-listed candidates shall be sent by POST/EMAIL on the addresses provided by them in their applications forms.
