



## MEMORANDUM OF UNDERSTANDING

BETWEEN

CENTRAL UNIVERSITY OF JHARKHAND, RANCHI, JHARKHAND, INDIA

AND

BUSAN UNIVERSITY OF FOREIGN STUDIES(BUFS), BUSAN, REPUBLIC OF KOREA

That Relationship between **Central University of Jharkhand**, Ranchi, Jharkhand, India and **Busan University of Foreign Studies**, Busan, Republic of Korea, Governed by this MoU in which Central university of Jharkhand,(hereinafter referred to as CUJ),a Central University established under an Act of Parliament of India (Central Universities Act,2009) located at Ranchi, Jharkhand,India and Busan University of foreign studies (hereinafter referred to as "BUFS"),located in Busn, Republic of Korea, have reached the following understanding and bind the parties to specific commitment to each other, mutually.

### Article I

- 1.1 The purpose of this Memorandum of Understanding (MoU) is to establish a co-operative relationship through mutual interests and to advance the objectives of both institutions and collaborative ideas in the fields of foreign language (Hindi and Korean) education and Social Sciences.
- 1.2 That both institutions mutually intended to collaboratively pursue the following activities: -
  - (a) Joints seminars, lectures, symposia, workshop and other research meetings.
  - (b) Joint research projects on Hindi and Korean Teaching and Learning.
  - (c) Establishment of joint research platform for Faculty and Student.

- (d) Short term research visits based on invitation of the department or University.
- (e) Development of the standards of Hindi learning and curriculum framework.
- (f) Development of a standardized Hindi proficiency testing.
- (g) Development of a curriculum and instructional material for foreign languages (Hindi & Korean) course.
- (h) Development of special academic language programs for BUFS and CUJ students.
- (i) Exchange of Students and Faculty members.
- (j) Other Research activities mutually agreed on to.

## Article II

- 2.1 That the details of each research program or project shall be arranged by mutual consent and both institutions may enter into a separate agreement signed by each of their authorized signatories that describes the terms of the agreements, including the budgets.
- 2.2 That the both the institutions shall abide by all rules, regulations, policies and procedure of their respective institutions regarding the disclosing and handling of Intellectual properties, developed technologies and confidential information that may arise under this MoU or otherwise.
- 2.3 That all information and/or data exchanged, acquired and shared in connection with the areas of cooperation between both institutions pursuant to this MoU shall be treated strictly confidential and shall not under any circumstances be divulged by the host institutions except mutually agreed or unless such information has already been in the public domain.
- 2.4 That any cost and expenses that may be incurred by jointly performing research activities shall be negotiated and agreed upon to the satisfaction of both institutions before starting such programs and activities.
- 2.5 Any claim, dispute, contrary action between the party arising in whole or in part under on in connection with this agreement or the subject matter hereof, shall be dealt & settle mutually by reasonable effort of both the parties.
- 2.6 That if any dispute fails to settle under the clause 2.5, the dispute shall be referred to the arbitration bench, particularly formed for this purpose & the settlement of dispute shall be governed by "the Arbitration & Conciliation Act 1996".

### Article III

3.1 This MoU shall be in effect from 21<sup>st</sup> Nov, 2023 & shall continue in force for a period of 05 years from the effective date. Both Institutions are at liberty to terminate this MoU by providing sixty (60) days advance notice to other institution. The period of 60 days shall be counted from the day of issue of the termination notice.


3.2 No amendment of the terms and condition of this MoU will be effective, unless made in writing, signed and communicated by each institution's authorized signatory.




