It is to notified for information of all concerned that henceforth all Certificates and Mark-Sheets and other educational documents presented through Digilocker platform are to be accepted as authentic and genuine. These electronic records available in Digilocker platform are valid documents as per provision of the Information Technology Act, 2000. Link: https://shorturl.at/96G0i.

Considering the admission process for the ongoing academic session and the significance of this important Digital initiative in the Higher Educational Institutions, the following are to be done:

- 1. The ABC IDs for the students may be created and captured for the academic year 2024-2025.
- 2. The students who were enrolled in the academic year 2023-2024 and earlier but not yet opened their ABC accounts may create their own IDs and submit the Head of the Departments, which then may be forwarded to the Examinations not later than 21<sup>th</sup> October, 2024, for linking/mapping the ABC Ids of students with Samarth Portal for credit accumulation at the time of academic credit data uploading.
- 3. Reference is also invited on the email dated 19<sup>th</sup> June, 2024, send to all HoD's of different departments of the university where in KPI score of the university stood at 85.39%.
- 4. It is understood that 14.61% ABC IDs of the scholars have not been mapped in either due to issues such as DOB, Enrolment Number, Name mismatch with the Samarth Portal. All HoD's are requested to kindly apprise the department on the email dated 19<sup>th</sup> June,2024 for increasing the KPI score to 100% at the earliest.

As you are aware that Academic Bank of Credits (ABC) is an online repository of academic awards (Degrees, Diplomas, Certificates, Mark-Sheets, etc.) lodged by the academic institutions/boards/eligibility assessment bodies in a digital format. It is a 24x7 online mode for making available academic awards and shall help in validating their authenticity, safe storage and easy retrieval.

The DigiLocker platform of the Ministry of Electronics and Information Technology, Government of India has the facility to pull students' academic documents into the issued documents section in an electronic form once uploaded through the DigiLocker-ABC platform by the original issuer. These electronic records available on DigiLocker platform are valid documents as per the provision of the Information Technology Act, 2000.

Earlier, the UGC vide its letters of even number dated 3<sup>rd</sup> January, 2022 and 21<sup>st</sup> September 2022 had requested the Higher Educational Institutions (HEIs) to accept degrees, marks sheets and other educational documents available in issued documents in DigiLocker account as valid documents. Therefore, all HEIs are once again requested to accept the digital copy made available in the DigiLocker platform by the various Boards including Central Board of Secondary Education (CBSE) and other recognized institutions, as its legally valid documents.
