- Anti-ragging affidavit was made compulsory at the time of admission for newly-admitted students in the session 2023-24 admission years. Every student is made to sign an elaborate oath, pledging never to indulge in or support any sort of ragging activities in the University.
- On the website the Anti ragging handle was created and it is made clear that any ragging activity in the University will be severely penalized using legal actions.
- Anti-Ragging posters are displayed throughout the University premises to spread awareness about UGC regulations.
- Central University of Jharkhand policies and practices are directed toward 'zero tolerance on Ragging'. The University has not reported any incident in academic year 2023-24.

Annual Report on Anti-Ragging

(2021-22)

The Central University of Jharkhand organised many Anti-ragging initiatives for creating a safe and respectful environment for students. The COVID-19 situation had restricted the senior-junior interactions but precautions were taken to avoid any incidents. Some key Anti-Ragging initiatives and measures taken by the university are as below:

UGC Policies and Regulations: The University through Departments created awareness abbot comprehensive Anti-Ragging policies and codes of conduct. The CUJ has adopted and aligned institutional policies with national and regional laws on ragging. The students have been made aware of these laws and the consequences of violating them.

Awareness Campaigns: Each Department in the beginning of the new academic year organised Orientation Programs for new students highlighting the dangers of ragging and the institution's zero-tolerance policy.

Support Systems: Helplines and reporting mechanisms for students to report incidents of Ragging without fear of retribution have been advertised across the campus through posters and hoardings. The same has been put on the website.

Enforcement Mechanism: There is regular monitoring of student interactions and activities, including CCTV cameras in common areas. The Proctorial Board has the mandate to ensure that the process is transparent and that victims receive protection from retaliation. Each Hostel has notified residents to fill Anti-Ragging affidavits.

The CUJ promotes an inclusive and respectful campus culture through events, cultural activities, and initiatives that bring students together and build mutual respect. Student mentors encourage the formation of peer support groups that can provide guidance and support to new students.

No Case of Ragging has been reported in the academic Year 2021-22.
