India has adopted the visionary and innovative policy document, NEP-2020 to transform the overall education system of India keeping in view the benefit to the students and the nation. The NEP-2020 envisions making India a developed nation (Viksit Bharat) and reaching the goals of converting India into a Vishwaguru. NEP-2020 has been implemented all over India and Central University of Jharkhand is first among the higher education institutions (HEIs) from Jharkhand to have implemented NEP-2020 and launched the integrated UG-PG Courses in the year 2022 onward. The NEP-2020 promotes multi-disciplinary courses with multiple entries and exits. It requires collaborative approach at the regional, state and national level where the higher education institutions should come together to work for developing the learner centric approach by offering courses, research, industrial and life skills and extension activities as per their expertise. The true implementation of NEP-2020 would only happen when the HEIs would come together to learn from each other and seek a collaborative approach in offering their expertise for development of the region, state or nation. Thus, the UGC has mandated the centrally funded HEIs to have interaction with other education institutions from their region in order to learn and seek collaboration for the proper implementation of NEP-2020. In doing so, all the Centrally

Funded Institutions are required to organize a conclave to build consensus with the state universities and institutions for the proper implementation of NEP-2020. The process is meant to learn from each other and develop a mechanism for the effective implementation of NEP-2020. The implementation needs to be done as per the 25 identified key theme areas of National Education Policy 2020 which are put below:

#### Key Theme Areas of National Education Policy - 2020

- 1. Holistic and Multidisciplinary Education.
- 2. Access to Higher Education.
- 3. Equity and Inclusive Education.
- 4. Gender Sensitivity and Equality in Education.
- 5. Curriculum & Assessment Reforms.

- 7. Academic Research & Innovation.
- 8. Multiple Entry & Exit and Flexibility-credit transfer systems and recognition of prior learning.
- 9. Quality Assurance.
- 10. Governance Phasing out the traditional affiliation system and promoting autonomous institutions with decentralized governance.
- 11. Collaborative Learning through Digital Platforms.
- 12. Open & Distance Learning (ODL).
- 13. Internationalization of Higher Education.
- 14. Vocational and Professional Education.
- 15. Industry-Academia Linkage.
- 16. Capacity Building of Faculty of Higher Education and Continuous Professional Development.
- 17. Scholarship, Loans and Public-Philanthropic Partnerships in Education.
- 18. Student Support Services such as career counseling, mental health resources, and academic advising.
- 19. Funding and Resource Allocation.
- 20. Adoption of National Higher Education Qualification Framework and National Credit Framework.
- 21. Leveraging Educational Technologies for better learning outcomes.
- 22. Embedding Indian Knowledge System in Higher Education.
- 23. Use of regional languages in teaching and learning.
- 24. Promoting Research on Indian Languages and Linguistics.
- 25. Inclusion of Arts, Culture, and Heritage in Education.

As per the mandate, the CUJ has been asked to lead and have interaction with other four selected institutions from Ranchi, viz., Ranchi University, National University of Study & Research in Law, Jharkhand Raksha Shakti University and Dr. Shyama Prasad Mukherjee University. In view of the given thematic areas, the Central University of Jharkhand is organizing one day 'Regional Conclave on Monitoring and Outreach-NEP-2020' where the selected four universities from Ranchi (Ranchi University, National University of Study & Research in Law, Jharkhand Raksha Shakti University and Dr. Shyama Prasad Mukherjee University) would be participating

in the conclave as required by the UGC. The conclave would have participation of the officials related to NEP implementation, from these universities to come together to deliberate on the topic and identify their best practices for mutual benefit and development.

## Objectives

The objectives of this conclave are to:

- Develop a collaborative platform with the participating HEIs through dialogue and discussion on NEP-2020;
- Learn from each other their NEP implementation process by analyzing the scope of implementation, resource allocation and challenges faced in the same;
- Identify areas of collaboration with the participating HEIs for the proper implementation of NEP-2020;
- Build consensus on the issues related to NEP-2020 through mutual agreement;
- Develop a vision document for collaboration between the participating HEIs for future initiatives in the effective implementation of NEP-2020; and
- Identify the possibilities of MOU with the participating HEIs for mutual benefit in consonance with the vision of NEP-2020.

# **Role of the HEIs:**

- 1. There will be a round table discussion where all the participating universities will present their NEP implementation process. The SWOT analysis of the same for the learning of all would be done by all participating universities. The best practices and challenges faced in doing so by the HEIs will be highlighted. Also, the kind of approach in addressing the challenges and planning to implement for the solution of the same.
- 2. The outcome of the conclave would be a combined Vision Document for the proper implementation of the NEP-2020 in the participating universities. The collective programmes, research and activities by utilizing each other's resources (human resource, specialization and expertise and financial support) and assisting each other to grow would be discussed. This would be finalized in view of the NEP-2020 themes and participating universities' interest in offering support in the area of their expertise. The vision document may be signed on the same day or a few days later with the consent of all participating universities interest in offering support in the area of their expertise.
