- I. Quotations without any erasures and overwriting must be submitted in sealed cover addressed to The Technical Cell(I/c) ,Central University of Jharkhand, Manatu, Ranchi, 835222 and should reach on or before 03.02.2025 at 11.00 AM. super-scribed Tender/ Enquiry No. and the due date failing which, quotation may be ignored. Tender/ quotation should be sent through Post/ Courier/ Email/By Hand.
- II. The rate quoted should be inclusive of all taxes, and should remain valid for our acceptance for minimum period of six months from the due date of opening of the quotations.
- III. The University will not entertain requests for revision in prices once quoted for whatever reason after the tenders are opened during the period of contract.
- IV. Only web hosting firm with parameters as mentioned in Annexure 1 need apply. Preferences will be given to the bidder nearby Ranchi.
- V. GST Registration Number and its validity should be indicated. Documentary evidences be supplied/ attached to the tender documents.
- VI. All rates shall be indicated both in words and figures. Where there is difference between the rates quoted in words and figures, rate quoted in words will prevail.
- VII. The Tender Document will be single bid system consisting of Annexure-1.
- VIII. All legal disputes shall be under the jurisdiction of Jharkhand High Court, Ranchi.
- IX. The University reserves the right to accept or reject any Bid, without assigning any reason thereof. No correspondence in this regard will be entertained.
- X. The selected vendor shall enter into a 5-year agreement with the Central University of Jharkhand (CUJ) on non-judicial stamp paper. The agreement will include a commitment to ensure **zero downtime** of the CUJ website post-hosting.
