Call letters for attending interview will be sent only to the short-listed candidates by E-mail. No correspondence will be entertained with the applicants who are not short-listed to be called for interview.* Hence, if the number of eligible candidates increases more than the reasonable number as decided by the University, only shortlisted candidates shall be called for interview.
