IMPORTANT NOTE: Provisionally Eligible candidates are being allowed to appear before the Selection Committee subject to production/submission of requisite document as mentioned against their Form No. on the date of Selection Committee Meeting failing which they shall not be allowed to appear before the Selection Committee.
