- e. One years M.A./M.Com../Post Graduate Diploma in Concerned Programme
- f. Two years M.A./M.Com.

III. For all Technology Stream

- a. One Year UG Certificate (Engg.)
- b. Two Year UG Diploma (Engg.)
- c. Three Year B.Voc. (Engg.)
- d. Four YearB.Tech/B.E
- e. Two Years M.Tech/M.E.

It is further notified that the existing batches for the admission years 2022, 2023 and 2024 shall follow the 5 Years Integrated Post Graduate Pattern as per the existing UGC Regulations/NHEQF.
