

PUBLIC NOTICE

The Vivekananda Central Library, Central University of Jharkhand, Ranchi, is organizing a two-day Book Exhibition from **8.10.2025** to **9.10.2025** at its premises located in Cheri-Manatu, Ranchi. The timings for the same will be 10:00 AM to 05:00 PM

The objective of this exhibition is to showcase recent publications aligned with the revised syllabus developed under the Five-Year Integrated Programmes and the National Education Policy (NEP) 2020. The list of programmes and courses is available on the University website: https://cuj.ac.in.

Publishers/Vendors possessing an authorization letter from the concerned authority and willing to participate in the Book Exhibition may express their interest by sending a confirmation email to al@cuj.ac.in within one week from the date of publication of the notice on the University website.

The detailed terms and conditions for Book exhibition 2025 are as follows:

- Vendors/Publishers must complete the stall booking process through the official registration
 procedure prescribed by the University Library. This process is mandatory for participation.
 Booking of a stall will only be confirmed upon successful completion of this registration
 process.
- 2. Discount: For Text Books 25% and for Reference Books 30%.
- 3. In view of the limited number of stalls (i.e., 20 in total), the principle of "first come, first served" shall apply. Stall space will be allotted based on availability. Subletting or transfer of stall rights is strictly prohibited.
- 4. Only approved books and materials relevant to academic and research interests shall be displayed. Prior clearance may be required for certain categories. Any form of promotional activity beyond the stall premises requires prior permissions.
- 5. The Purchase Order of recommended books will be placed to the concerned publishers/authorized vendors as per university norms. The University may place the Purchase Order to supply books as recommended by the respective departments during exhibition period.
- 6. The University Library shall not be held responsible for any loss, damage, or legal liability arising during the exhibition. Vendors/Publishers must comply with all applicable institutional and legal norms.
- 7. The use of materials or decorations that may damage university property is strictly prohibited.
- 8. Any violation may lead to immediate cancellation of participation without refund.



- 9. It is hereby clarified that only one stall shall be allotted to each vendor/publisher. Therefore, no request or claim for more than one stall will be entertained under any circumstances.
- 10. An amount of Rs. 6000/- (Six thousand rupees only) shall be paid online by the participants as participation charge (table charge) in favour of 'Central University of Jharkhand, Ranchi in the following Bank:

Publishers or authorized vendors who fail to submit the payment (with payment details via Google Form) by the stipulated deadline will not be considered for participation.
