**ADVERTISEMENT FOR THE POST OF PROFESSOR OF PRACTICE**

The Central University of Jharkhand (CUJ) established under the Central Universities Act, 2009 on 1<sup>st</sup> of March 2009 with a vision to develop enlightened citizenship of a knowledge society for peace and prosperity of nation and the world through promotion of innovation, creative endeavours and scholarly inquiry.

CUJ invites applications from distinguished professionals with non-academic / industrial background for faculty positions at the level of **Professor of Practice (PoP)** in its various academic departments / schools.

**Qualification & Experience**

- Distinguished experts who have made remarkable contributions in their professions from various fields such as engineering, technology, Economics & Development Studies, Management. Those who have proven expertise in their specific profession or role with at least 15 years of service/experience, preferably at a senior level, will be eligible for Professor of Practice.
- A formal academic qualification is not considered essential for this position if they have exemplary professional practice in lieu. These experts will also be exempted from the requirement of publications and other eligibility criteria stipulated for the recruitment of faculty members at the Professor level. However, they should possess the skills to carry out the duties and responsibilities specified by the University.

**Remuneration:** Consolidated remuneration of Rs. 1-2 lakh per months will be paid depending upon experience and qualification.

**Duties & Responsibilities:**

The duties and responsibilities include development and designing of courses and curriculum; delivering lectures; engaging students in innovation & entrepreneurship projects and providing mentorship for these activities; helping the University in forging industry-academia collaborations; carrying out research project or consultancy services in collaboration with the regular faculty members of the University; delivering special lectures and training programmes.

Candidates with good academic record throughout and have minimum 15 years of professional experience. They should have a track record of exemplary professional practice while serving in leadership positions and have a well-established, evidence-based reputation for superior accomplishments in their fields.

**Leave:** The consultants will be entitled for the paid leave at the rate of 1 (one) day for each complete month of service. Accumulation of leave beyond calendar year may not be allowed. In special circumstances, the Consultant could be called for services on holidays or beyond normal working hours for which no extra remuneration will be paid.

**General Information /Conditions:**

1. The position will remain open till filled.
2. The University reserves the right not to fill up any / all position(s) / select any candidate without assigning any reason.
3. Mere fulfilling of the minimum qualifications and experience will not confer any right to the candidates for being called for interview or/and for his/her selection. In case of large number of applications, the scrutiny committee may apply benchmarks higher than minimum essential/desirable qualifications to shortlist the candidates for interview.
4. The CUJ strives to have a workforce that reflects gender balance and women candidates are encouraged to apply.
5. Applicants selected for appointment may be required to go through police verification before or after joining.
6. Candidates should enclose self-attested copies of certificates towards the evidence of age, educational qualifications, remarkable contribution in their profession experience etc. with the applications.
7. The selected candidates will be governed by the Act, Statutes, Ordinances, Rules& Regulations of the University.
8. The University will communicate only with short-listed candidates.
9. No correspondence will be entertained during the process.
10. Canvassing in any form will be a disqualification.
11. Incomplete applications will be rejected summarily.
12. Since it is an open-ended advertisement, there is no last date for receiving applications. However, the first shortlisting of candidates would be undertaken **after 30 days** from the date of issue of this advertisement on the website of the University.
